What is insured?

Other Exceptions referred in the Policy



Are there any restrictions on cover?

- We will not cover the amount of the Deductible or that of the Excess
- We will not pay more than the limits specified in your Policy Schedule



Where am I covered?

In the Republic of Cyprus only where the Government have effective control - Court and Laws of the Republic of Cyprus



What are my obligations?

- You must pay the premium within the payment period, agreed with the Company
- In case of an event that may give rise to a claim based on the insurance policy, the Company
 must be notified immediately by the Contracting Party, the Insured Person and / or any of
 their representatives
- You must comply with the terms of the Insurance Policy
